

# **PUBLIC NOTICE OF NETWORK CHANGE UNDER RULE 51.329(A)**

# **Hurricane Sandy's Destruction of Facilities**

April 25, 2013

Hurricane Sandy destroyed certain copper network facilities in Long Island, New York during October/November 2012. These facilities previously were used to provide service to the locations listed in Attachment A. Access to these facilities is no longer available. In connection with Hurricane Sandy, Verizon activated its disaster response plan for the affected areas.<sup>1</sup>

As a result of Hurricane Sandy, Verizon copper network facilities are no longer available to provide service at the locations listed in Attachment A, and certain unbundled network elements are no longer available for these locations.
