Description of the Planned Network Changes:

The Signaling System 7 (SS7) links originating from the following VZ MD end offices in the 242 Salisbury LATA will be rehomed from the VZ MD Easton (ESTNMDES77W) Signal Transfer Point (STP) and the VZ MD Salisbury (SLBRMDSB77W) STP to the VZ MD Baltimore (BLTMMDCH77W) and the VZ MD Pikesville (PIVLMDPK77W) STP in the 238 Baltimore LATA. SS7 services currently provided by the VZ MD Easton and VZ MD Salisbury STPs will, after completion of the network changes, be provided via the VZ MD Baltimore and Pikesville STPs.
