SS7 services currently provided by the VZ NY Newburgh (NWBRNYNW01W) STP and the VZ NY Poughkeepsie (PGHKNYSH01W) STP will, after completion of the network changes, be provided via the VZ NY Syracuse (SYRCNYSU04W) STP and the VZ NY Utica (UTICNYUT04W) STP. The SS7 links originating from the VZ NY end offices listed below will be rehomed from the VZ NY Newburgh (NWBRNYNW01W) STP and the VZ NY Poughkeepsie (PGHKNYSH01W) STP to the VZ NY Syracuse (SYRCNYSU04W) STP and the VZ NY Utica (UTICNYUT04W) STP.
