Description of the Planned Network Changes:

The Signaling System 7 (SS7) links originating from the VZ WV Keyser, WV end office (KYSRWVMRDS0) and the VZ WV Martinsburg, WV end office (MRBGWVBUDS0) will be rehomed from the VZ MD Baltimore, MD Signal Transfer Point (STP) (BLTMMDCH77W) and the VZ MD Pikesville, MD STP (PIVLMDPK77W) to the VZ WV Clarksburg, WV STP (CLBGWVMA77W) and the VZ WV Morgantown, WV STP (MGTWWVFY77W). SS7 services currently provided by the VZ MD Baltimore and Pikesville, MD STPs will, after completion of the network changes, be provided via the VZ WV Clarksburg and Morgantown, WV STPs.

Description of Reasonably Foreseeable Impact of the Planned Changes

SS7 service providers will need to alter their SS7 transport and OffNet services arrangements (services obtained from third parties) in order to access or continue serving the customers in the Keyser and Martinsburg VZ WV end offices. Alterations may be necessary for the VZ WV Charleston and Dunbar, WV STPs and the VZ WV Clarksburg and Morgantown, WV STPs dependent upon SS7 provider link terminations.
