1.5.2 Explanation of Service Rates: Service rates depend on the length of a call, the time period in which the call is placed, the class of service applicable to the call, the international location to which the call is terminated and, in some cases, the airline distance between the Company’s operating center

at which the call originates and the city in which the call terminates. All calls will originate from the Exchange closest to the calling party's physical location. The vertical and horizontal coordinates for that Exchange and the airline distance will be determined according to the V&H Coordinate table as used on an industry-wide basis. Calls that overlap rate periods will be charged according to the rate applicable to the time recorded in each period. Calls are billed in initial sixty (60) second and additional six (6) second increments or in one minute increments. The following charges, in U.S. dollars and cents, apply for Service calls. When applicable, additional minute rates apply to each minute or fraction thereof after the initial period.

1.5.3 Class of Service: The Company provides Direct Dial Service.

1.5.4.1 Pricing – Rates are based on calls between the countries listed and the Company's billing and rating locations.

1.5.4.1.4 Payphone Surcharge

To recover the Company's expenses to comply with the FCC's pay telephone compensation plan effective October 7, 1997 (FCC 97-371), an undiscountable per-call charge is applicable to all interstate, intrastate, and international calls that originate from any domestic pay telephone used to access Company services. This surcharge, which is additional to service usage charges and other applicable surcharges, applies to the use of the instrument used to access Company service and is unrelated to the Company service accessed from the pay telephone.

Pay telephones include coin-operated and coinless phones owned by local telephone companies, independent companies and other interexchange carriers. The Surcharge applies to the initial completed call and to any reoriginated call (e.g., using the A#@ symbol).

Whenever possible, the Surcharge will appear on the same invoice containing the usage charges applicable to the call to which the Surcharge applies. In cases where proper pay telephone coding digits are not transmitted to the Company prior to completion of a call, the Surcharge may be billed on a subsequent invoice after the Company has obtained the information necessary regarding the eligible pay telephone from which the call originated.

The Surcharge does not apply to calls placed from coin-operated telephones at which the Customer pays for service by inserting coins during the progress of the call.

1.5.4.1.5 Allegiance Calling Card Service

Standard Switched Usage rates apply to all international calls placed with the use of the Allegiance Calling Card. In addition, a per-call Surcharge applies, as shown below, per type of call:

Surcharge - Direct-Dialed : \$0.60*

Surcharge - Station to Station Operator Assisted: \$1.35

1.5.4.1.6 Premium Code International Service

Premium Code International Service (PCIS) allows a Customer to place a call to a premium code international telephone number.

For a PCIS call, the overall charge billed will consist of an international long distance per-minute charge (for the carriage of the call) and a PCIS per-minute charge (for the content of the call or other product or service delivered in the course of, or as a direct consequence of, the call).

If a Customer uses Service in a manner that results in a PCIS call, the Customer will be responsible for all charges associated with the call.
