### 1.0 XO Switched Long Distance Business Plan

1.1 Description of Service: XO Switched Long Distance Business Plan is a measured outbound, inbound, direct-dialed long distance calling plan where Customer's local service is being provided by a carrier other than XO. Plan calls may originate from any location served by the Company and may terminate at any location within the coterminous United States, Alaska, Hawaii, Puerto Rico, U.S. Virgin Islands, Guam, and the Northern Marianna Islands or at international locations.

### 1.2 Special Terms and Conditions:

1.2.1 Toll-Free, Operator Assistance and Directory Assistance services are available to Customers of Plan Service pursuant to terms and conditions, including rates and charges, set forth on this website or in tariffs applicable to intrastate calls.
1.2.2 The minimum for a Plan call is sixty (60) seconds and, thereafter, a call will be billed in six (6) second increments.
1.2.3 Plan Service may not be used in connection with carrier or resell applications, auto-dialers, data transmission equipment, Centrex services, foreign exchange services, public telephone services, ISDN or equivalent services, calls to Internet Service Providers, broadcast facsimile applications, or aggregated end-user traffic such as that undertaken by educational institutions.

### 1.3 Rates and Charges:

1.3.1 For interstate calls, the per-minute rate is $\$ 0.069$.

1.3.4 Canadian Toll Free. Switched Toll Free calls originating from Canada will be billed at $\$ 0.15$ per minute. The minimum for a Toll Free call originating from Canada is sixty (60) seconds and, thereafter, will be billed in six (6) second increments.

### 2.0 XO Long Distance Business Plan

2.1 Description of Service: XO Long Distance Business Plan is a long distance calling plan available to Customers who subscribe to other Company interconnection services, as set forth in Section 2.2.1. Plan calls may originate from any location served by the Company and may terminate at any location within the coterminous United States, Alaska, Hawaii, Puerto Rico, U.S. Virgin Islands, Guam, and the Northern Marianna Islands. International calling is available at the rates set forth under the "XO Global International Long Distance" plan at www.terms.xo.com, but such calls are not included in the Plan.

### 2.2 Special Terms and Conditions:

2.2.1 To be eligible for the XO Long Distance Business Plan, Customer must subscribe to the Company's dedicated interconnection services, including local exchange or dedicated access circuits at each location.
2.2.2 Plan calling may involve outbound or inbound traffic, or a combination of the two.
2.2.3 A Monthly Recurring charge, as set forth in Section 2.3.1, will apply to each Customer location where Business Plan service is provided based on the particular Plan Package selected by the Customer for a location. For example, if a Customer enrolled in Business Plan 200 service at one location, Business Plan 500 service at a second location, and Business Plan 10,000 service at a third location, the Customer's Monthly Recurring charges for service at all three locations would be $\$ 300.00$, consisting of charges of $\$ 7.50$, $\$ 17.50$ and $\$ 275.00$, respectively.
2.2.4 Neither Directory Assistance calls nor Toll Free payphone charges are not included in the Plan and will be charged for separately at the rates applicable to such calls.
2.2.5 A Customer must select a Plan from the Long Distance Packages set forth in Section 2.3.1 based on the Customer's projected minutes of usage during a monthly billing period. Each Plan establishes the maximum number of minutes a Customer may use during a monthly billing period without being subject to the Overage Rate Per-Minute charges set forth in Section 2.3.1. If service usage during a monthly billing period exceeds the applicable maximum at a Customer location enrolled in a Plan, the Customer may select a replacement Plan more suitable to its higher traffic volumes.
2.2.6 Unused minutes during any monthly billing period will not carry over to a subsequent billing period.
2.2.7 The minimum for a Plan call is six (6) seconds and, thereafter, a call will be billed in six (6) second increments, except for the XO LD Business Plan with no Monthly Recurring Charge where the minimum is sixty (60) seconds and, thereafter, a call will be billed in sixty (60) second increments.
2.2.8 Plan Service may not be used in connection with carrier or resell applications, auto-dialers, data transmission equipment, Centrex services, foreign exchange services, public telephone services, ISDN or equivalent services, calls to Internet Service Providers, broadcast facsimile applications, or aggregated end-user traffic such as that undertaken by educational institutions.

### 3.0 XO Unlimited Long Distance Business Plan

3.1 Description of Service: XO Unlimited Long Distance Business Plan is an outbound long distance term calling plan available to Customers who subscribe to other Company services, as set forth in Section 3.2.1. Plan calls may originate from any location served by the Company and may terminate at any location within the coterminous United States, Alaska, Hawaii, Puerto Rico, U.S. Virgin Islands, Guam, and the Northern Marianna Islands. International calling is available at the rates referenced in Section 3.3.2, but such calls are not included in the Plan.

### 3.2 Special Terms and Conditions:

3.2.1 To be eligible for Plan Service, a Customer must commit to a service term of at least one (1)
year and subscribe to Company local services, including intrastate , intraLATA toll and interLATA toll.
3.2.2 Customer must subscribe to Plan Service for all lines at a Customer location, not to exceed ten (10) in number.
3.2.3 Toll-Free, Operator Assistance and Directory Assistance services are available to Customers of Plan Service pursuant to terms and conditions, including rates and charges, set forth on this website or in tariffs applicable to intrastate calls.
3.2.4 Plan Service may not be used in connection with carrier or resell applications, auto-dialers, data transmission equipment, Centrex services, foreign exchange services, public telephone services, ISDN or equivalent services, calls to Internet Service Providers, broadcast facsimile applications, or aggregated end-user traffic such as that undertaken by educational institutions.
3.2.5 The minimum for a Plan call is sixty (60) seconds and, thereafter, a call will be billed in six (6) second increments. The duration of a call for billing purposes will be rounded to the next higher increment. Fractional cents will be rounded to the next higher cent.

8.1 Description of Dedicated Long Distance Service: Dedicated Long Distance Service provides Customer, where technically feasible, with a dedicated facility from the Customer premise to Company's interexchange point of presence.
8.2 Minimum Annual Commitment: To be eligible for this product, Customer must agree to a minimum annual commitment level of at least $\$ 3,600$. If the Customer terminates its agreement before its expiration date, Customer is liable for any unfulfilled annual commitment amounts for each partial and entire year remaining in the contract term.

9.3 Chargeable Call Duration: Calls are billed in six-second increments.
9.4 Monthly Recurring Charge for Flat Rate Dedicated Services: Monthly Recurring charge for Flat Rate Dedicated Services includes a specified amount of monthly minutes of use for combined inbound and outbound interstate long distance service. Unused minutes may not be carried over to following months or other accounts held by Customers. Customers are eligible for discounts based on term and revenue commitments. The standard configuration involves having a single DS1 to the Customer's premises. Service can also be provided via ISDN PRI.
10.2 Customer Commitments: In order to receive this service, the Customer must purchase a minimum of six (6) local exchange lines or trunks and utilize a total of at least fourteen (14) voice \& data channels. The Customer must also enter into a one (1), two (2) or three (3) year service order agreement.
10.3 Discount on Interstate Long Distance Services: Customers who sign up for XO Integrated Access will receive a ten percent discount on all interstate long distance services. This discount will be applied in addition to any other volume or term discount associated with the Customer's base rate.
11.0 RATES FOR INTERNATIONAL MESSAGE TOLL AND TOLL FREE SERVICES. (This product and pricing will no longer be available to new Customers after September 19, 2005.)
11.1 Description of International Message Toll Service (IMTS): IMTS is a direct dialed communications service that is available for use by customers twenty-four (24) hours a day. Customers may originate IMTS from locations served by the Company, and may terminate in all locations listed in the applicable product descriptions.
