

## Amendment No. 4 to the Master Service Agreement

Amend Attachment D - Reporting and Administrative Fees Due to MiCTA as follows -

- Section D.1.4 Revised to state that administrative fees are to be paid within forty-five (45) days after the end of the calendar quarter.
- Section D.2 Required Sales/ Administrative Fee Reports– Change "Reports must be submitted by the 60<sup>th</sup> day following month-end close" to Reports must be submitted by the 30<sup>th</sup> day following the end of the last day of each quarter.

**3. No Other Modifications.** Except as provided above, the terms and conditions of the Agreement remain unchanged.
