 - a. Customer must purchase one new Pots line with Verizon Business via UNE-P delivery method.
 - b. Port existing telephone number (TN) to VZB as a Remote Call Forward Number and order a single call path.

2. Customer must

- a. Sign a Verizon Business Service Agreement that includes the CLEC Local Service attachment with Verizon Business Services III (VBSIII) pricing plan to purchase services including the Qualifying Services (the "Agreement").
- b. Submit the signed Agreement by November 30, 2019
- c. Order Remote Call Forwarding for existing affiliate POTS line with 1 call path and purchase the NEW POTS line with Verizon Business at standard pricing/discounts as per the VBS III contract to forward the RCF number by December 31, 2019
- d. Install the Qualifying Services by January 31, 2020.
- 3. Qualifying Services may be added to locations in the following jurisdictions: AZ, CA, CO, FL, GA, ID, IL, MI, MN, MO, MS, OH, OR, TN, TX, UT, WA
- 4. Customers who are not party to an Agreement (i.e., a new customer) must sign an Agreement with at least a minimum term of two years.
- 5. Customers who are already party to an Agreement (i.e., existing customers) must either: (a) have a minimum of 12 months remaining on their existing Agreement; or (b) if less than 12 months remains on their existing Agreement, extend their existing Agreement for an additional two-year term.
- 6. The rate listed in this promotion applies to a single RCF per path charge migrated from a qualified Verizon affiliate in one of the States listed in paragraph 3 in order to retain the qualified affiliate TN. Customer must also purchase a new UNE-P POTS line on Verizon Business and forward the RCF number to the new POTs line.
- 7. Once Verizon Business verifies that the RCF order has completed and that there is a related order for UNEP POTS, the promotional rate will be applied.
- 8. Orders may be expedited subject to payment of applicable expedite fees.
